### LIMITED WARRANTY MECHANICAL PROPERTIES:

Titanium 40220 HSB series ESD Floor Mats from United Static Control Products are warranted for a period of twenty years from the date of installation to be free from defects in material and workmanship if installed, maintained and used in strict accordance with United's written installation instructions.

### LIMITED WARRANTY ELECTRICAL

#### CONDUCTIVITY AND STATIC GENERATION:

Titanium is further warranted to meet the posted specifications of  $>2.50E04$  and  $<1.0E06$  ohms resistance to electrical ground when tested to ANSI ESD S7.1 for the usable service life of the tiles when installed using United's specified installation parameters.

Further, Titanium is warranted to meet ANSI ESD S20.20-2021 Table 2 (page 6) Personal Grounding Requirement Product Qualification (ANSI/ESD STM97.1 and ANSI/ESD STM97.2) and Table 3 (page 8) EPA ESD Control Items, Flooring Product Qualification

### NOTIFICATION OF CLAIMS AGAINST

WARRANTY: This warranty does not cover dissatisfaction, problems or damage due to installation or maintenance. All claims under this warranty must be submitted in writing within five (5) business days of discovery to:

OBLIGATION OF WARRANTOR: Buyer's exclusive remedy against United Static Control Products for claims arising hereunder for any and all losses and damages resulting from any cause shall be receipts of, at United's option, either replacement of the defective merchandise, or a refund of the sale price of the defective merchandise.

In no event shall United SCP be liable for incidental or consequential damages, even if some other provision of this Limited Warranty is unenforceable. Buyer waives all other claims and remedies of any nature.

Titanium is not designed for use in or near commercial kitchens or for outdoor use. United Static Control Products shall have no liability whatsoever to Buyer in the event the goods become defective if such defect is caused in whole or part by cuts, tears, vandalism, willful destruction, vapor intrusion from concrete of  $>5$  lbs. over a 24 hour time frame (when tested using standard calcium chloride trays), improper installation, improper maintenance, accident, or act of God. Ground cords are NOT covered by this warranty.

Titanium is not warranted against compromised chair caster traffic or cracking. Titanium is not warranted against plasticizer migration from tapes or mats placed on top of the flooring nor carbon sloughing from the backing.
